

Fact Sheet:

Optional Practical Training (OPT)

OPT gives employers a discount for not hiring American workers.

Employers save roughly 8 percent when they hire foreign students or graduates instead
of U.S. workers because they don't have to pay FICA or Medicare taxes under the
Optional Practical Training program (OPT).¹

OPT denies Americans jobs.

- Employers may hire through the OPT program as long as the job is related to the student/worker's area of study.²
- Job ads specifically seek OPTs, who by definition cannot be American.³

OPT costs the Social Security and Medicare trust funds billions of dollars.

 OPT workers often hold jobs in the \$60-\$90,000 a year range, but they cost Social Security and Medicare about \$4 billion dollars every year.⁴

OPT workers are not guaranteed a prevailing wage.

• There are no enforceable wages protections, allowing employers to undercut local prevailing wages by exploiting foreign students/workers.⁵

Congress never voted to create the OPT program as we know it today.

- A Microsoft lobbyist pitched the idea to the Secretary of Homeland Security at a dinner party in 2008.⁶
- The idea was to extend the length of existing "practical training" regulations so they could function as a new guest worker program that could help employers get around the cap placed on H-1B visas for white-collar jobs.
- The Bush administration created the current OPT program by executive fiat⁸; the Obama administration expanded it further⁹; the Biden administration added 22 new fields of "study" to the program.¹⁰

More employers are taking advantage of the government discount on not hiring Americans.

- Use of the program grew by 400% between 2008 and 2016; 1.5 million foreign graduates of U.S. schools used the program; 53 percent were in STEM fields; surpassing the H-1B program in size.¹¹
- Over 500,000 foreign students were authorized to work the practical training program in 2023.¹²

The U.S. government even offers the don't-hire-a-citizen discount to employers in sensitive areas such as Strategic Intelligence, Undersea Warfare, and Combat Systems Engineering.¹³
